## Parent Agreement & Code of Conduct

The following information and Parent Code of Conduct on page two is intended to establish our mutual expectations and avoid any disputes that may arise during the season.

### Sponsor Support

All WPFC players are encouraged to wear Adidas soccer shoes and goalkeeper gloves and to support all other club sponsors

### WPFC Uniform Purchase

WPFC asks its players to purchase uniforms every two years. 2012 is an "on-year", which means that all players are required to purchase a full team kit.

### WPFC Practice Attire

WPFC training shirt must be worn at training sessions, and players are encouraged to wear matching shorts and socks

### WPFC Schedule Expectations for the Year

#### Practice

- Black teams are expected to train 3 times per week year round
- All other teams train 3 times per week when on grass, 2-3 times per week in the winter

#### Spring/Summer Tournaments

- Black teams (U12 and above): 1 or more tournaments outside WA
- Rainier Challenge (June)
- Crossfire Challenge (July)
- GRFC Winter Classic (January)
- League Play: RCL, ECNL, WCDA and any other league WPFC participates in as a club

### State Tournament

If your team gets eliminated from postseason play you will still practice a minimum of 2 days per week until your age group tryouts

### High School Age Teams

- Teams are expected to train more often in the summer months to offset the lighter training schedule
- During the high school soccer season, coaches may also be attending high school games.
- Some teams may be required to attend a College Camp

### Parent Code of Conduct

WPFC strives to create champions both on and off the field. We believe that it is the duty of every member of the club, including our Board of Directors and coaching staff, to create the most positive environment possible for all players when participating in any WPFC function, including training sessions and games. By parents adhering to the following Code of Conduct, we believe that it will assist our players in their development as both soccer players and productive, responsible young women and men. Therefore, the undersigned parent agrees:

1. To abide by WPFC's Bylaws, published policies and procedures.
2. To refrain from teaching players unsafe or unsportsmanlike conduct.

3. To accept the decisions of the referee, no matter how unfair they may seem. The undersigned acknowledges and agrees that WPFC will not tolerate the verbal or physical abuse of referees and constitutes grounds for immediate termination as a member of WPFC.
4. To provide all players with a positive and safe learning environment that encourages respect for all.
7. To support the goals and objectives of the coaching staff and Directors of Coaching.
8. To support the player's participation by being on time for all training sessions and games, providing the necessary transportation to and from WPFC activities and being fiscally responsible to pay club dues and team expenses.

I understand and agree that any violation of this code of conduct may result in a range of consequences (depending on the severity of the infraction), including, but not limited to permanent loss of club membership in WPFC. Such consequences shall be determined by the club's Technical Director and/or the Board of Directors.
